About the Hong Kong Legal Walk

The Hong Kong Legal Walk is a charity and community-led initiative that brings together professionals from across Hong Kong's legal sector to support those in need from our local community.

How it works

From **1 October to 8 November**, teams take part by organising their own charity walks and fundraising efforts. Teams choose the date, distance, and location of their walk, while competing with other teams for HKLW prize categories and a place on the fundraising leaderboard.

Teams are encouraged to share their efforts on social media by tagging the HKLW LinkedIn page and using #HKLW. Upon registering via the HKLW website, participants receive a dedicated fundraising page to track donations. Walk as a team, individually, or invite clients to join!

Who takes part?

Participants come from across the legal community, including law firms, in-house legal teams, professional services providers, chambers, and barristers. Individuals and teams are welcome, and those supporting or working closely with the legal sector are also encouraged to get involved.

Charitable impact

100% of funds raised go towards supporting three charity beneficiaries focused on the welfare of Hong Kong's underprivileged, elderly, and youth, as well as organisations providing pro bono legal services and legal rights awareness. Since launching in 2022, the HKLW has raised more than HKD 3,000,000 and has supported a wide range of impactful charities.

We are delighted to share that the HKLW 2026 supported charities are **ImpactHK, Pro Bono HK, and Hong Kong Dog Rescue (HKDR)**.

Established in 2014, Pro Bono HK is an independent non-profit organisation dedicated to ensuring equal access to justice for Hong Kong's most vulnerable and marginalised communities. We bridge the justice gap by mobilising a network of volunteer legal professionals and trained law students to provide free frontline legal advice, case triage, and legal literacy programmes. Through our community legal clinics and hotline, we empower individuals to safely navigate complex challenges and protect their fundamental rights.



Hong Kong Dog Rescue (HKDR)
